請描述擬討論之議題 /Specific Issues of Discussion and Description	<p>The collaborative decision-making approach to Internet policy development has grown in understanding since its emergence in early 2000s, but in recent years, the development of the multistakeholder model on which the Internet was built has shown signs of slowing, with some governments pushing their own agendas related to privacy, censorship, encryption, Internet shutdowns, among other public policy issues, through traditional legislative and regulatory processes.</p> <p>The Philippines' newly-launched National ICT Ecosystem Framework (NICTEF) is a recent success story of how the multistakeholder model is embraced in practice.</p> <p>NICTEF is a living document whose plans, programs and projects will be updated periodically as the government continually considers comments from all sectors of society and other indicators and results. In particular, sub-committees will be created to more effectively respond and cater to the needs of the countryside. Regular updates will be made available on the framework's website.</p> <p>The workshop is a case study that will describe how the framework includes multistakeholder inputs and what the opportunities and challenges are of putting the model in action.</p> <p>The session will invite participants to engage in a discussion about key elements of the Philippine framework and explore how they could be replicated in the Taiwan context. It will also look into possible opportunities and challenges of using the multistakeholder model in practice, and speakers will be asked to provide commentary on the current use of the multistakeholder model in Taiwan and identify opportunities to replicate elements of the Philippine example.</p>
