Mr. Kuo Wei Wu (Chairman, Board of TWIGF)

Kuo Wei was the deputy director of National Center for High-Performance Computing (NCHC) in Taiwan between 1990 and 1998, where he worked to develop national supercomputing policy and national academic networking policy and its implementation. From 1998 to 2000, he was the senior vice president of Yam Digital, Inc. which was the major internet portals in Taiwan. He led the marketing and sales department. By 2000, he was the vice president of Acer, Inc. which is the leading PC industry in the world. He developed SMB business service model and led a new business unit in Acer, Inc.

Kuo Wei entered NII-EPA as CEO in 2004 dedicated to Internet governance research and promotion. During 1999 and 2010, he served as Executive Council member of APNIC, board member of Public Interest Registry (PIR). He was appointed by Address Supporting Organization (ASO) to be the ICANN board member in 2010, and reappointed by 2014 to be the ICANN board member until 2016.

He holds a BS degree in mathematics from Tunghai University, Taiwan, a MS degree in mathematical science from University of Cincinnati, USA, and another MS degree in computer science from Columbia University of New York, USA.

Maarten Botterman is independent strategic advisor on Internet Governance and related issues with 25+ year experience in guiding governments and major organizations on the economic/business and societal impacts of current and future internet innovations and technologies. During those 25+ years he participated and led more than 50 international projects and studies for governments and industry on Future Net issues with teams including experts with advanced academic degrees from many disciplines ranging from technology and mathematics to economics and law, and from many different countries and cultures.

Maarten was employed as Head of Unit and Senior Advisor to the Dutch Government (1987 – 1995) and as Scientific Officer to the Communications Technology Research program that was run by the European Commission (1995 – 1999). When working for RAND Corporation, he set up and ran an Information Society policy practice in Europe (1999 – 2006), and since, working as independent strategic advisor to governments and businesses in close cooperation with leading independent research institutions in Europe.
